Italicized: Countries where approval is granted via Notification and/or Import Permit. Notification refers to documentation, other than a registration dossier, that is reviewed and approved by the Health Authority; an Import Permit is an authorization by a competent authority for the importation of product into the country.

Asterik (*): Product available through distributor.
